CONDITIONS STIPULATED FOR RE-ENGAGEMENT

1. The maximum Age limit for re-engagement shall be 64 years ,6 months & this limit shall not be exceeded in case of any retired employee during the period of re-engagement
2. The re-engagement is purely on temporary basis and the staff will be discharged as & when suitable regular incumbents joined the post either by way of recruitment (RRB) or by transfer from other Units/Divisions/Railways or on attaining the age of 65 years or on cessation of the scheme or due to surrender of post on man power planning or administration does not require the services whichever is earlier.
3. Monthly remuneration of the re-engaged retired Railway supervisors will be determined as per Board's ltr.No.E(NG)II/2007/RC-4/CORE/1 Dt.24.10.2019(**PBC No 258/2019**)
4. Suitability/competency of the staff wherever required will be determined before the re-engagement.
5. Retired supervisors being re-engaged should not have been covered under the Safety Related Retirement Scheme/ Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS).
6. The working hours of re- engaged supervisors will be same as that of the regular staff in similar post.
7. Eight days leave (on Pro-rata basis) in a calendar year will be admissible as per RBE No.118/2019 (**PBC No.166/2019**)
8. The period of such re-engagement will not be counted as service for any purposes as admissible to regular serving employees and cannot claim pensionary benefits.
9. Re-engaged supervisors will not be entitled for PLB or any other extra benefits as admissible to serving employees.
10. Re-engaged supervisors will not be covered for any coverage under ECA, PWA, Payment of Gratuity Act or any other statutory enactments admissible to serving railway employees.
11. Re-engaged supervisors will not be covered for any of the Welfare Scheme, CGA, Ex-Gratia Funeral Advance etc as admissible to regular employees.
12. Re-engaged supervisors will not be entitled for any advances as admissible to regular employees.
13. The service of Re-engaged RRS can be terminated after giving notice period of one month.
14. This scheme will be valid till further orders.
15. While re-engaging such supervisors, medical fitness for the appropriate category will be done from the designated authorities as per existing practices
16. The administration can terminate the services of re-engaged persons at any time in case the work/conduct is found to be unsatisfactory
17. The re-engaged supervisors will be responsible for all safety aspects in Railway after engagement. Any failure will lead to necessary action on them.
