1. The employees should be free from DAR/SPE/Vig cases on the date of relief.
2. The employees will take the seniority in the new seniority unit to which they are transferred as per extent rules.
3. They will not seek re-transfer to their parent unit/Railway at a later date.
4. As the transfer is ordered at their own request, they will not be eligible for transfer passes, TA, Transfer grant, joining time etc., on transfer account.
5. The above transfer is subject to the condition that there is no DAR/SPE/Vigilance Cases pending against them on the date of their relief.
6. The employees may be relieved with proper Identification Memo and attested Passport size photograph, signature and thumb impression in terms of instructions contained in Rly. Bd's letter No.E(NG)I-2001/TR/16 dtd. 21.11.2001 and letter No.E(NG)I 2007 /TR/26 dtd. 04.12.2007.
7. The employees are hereby advised that in terms of Railway Board's letter No.E(NG)I-2006/ TR/6 dt.21.04.06 & 12.11.2009, no request for backtracking from the mutual exchange arrangement will be entertained under any circumstances.
8. In terms of Rly Bd's letter No.E(NG)1-2017/TR/24 (RBE No.65/2018) dt:09.05.2018 All mutual transfer cases where NOC has been given by both the Railway/Units i.e. accepting and relieving, both the employees should be spared immediately within a week, without either unit waiting for the reliever.
