The under mentioned candidate, who have been selected through RRB for appointment to the post of Assistant Loco Pilot in Level 2 of Pay Matrix, on having accepted the offer of appointment and on being found Medically fit in class AYE ONE was sent for initial training from 26.10.2023. He has failed in the GRS Course conducted between 26.10.22 to 28.11.22 and again directed to undergo GRS repeat Course from 06.03.23 to 10.04.23 and completed the training successfully.

He is absorbed as Assistant Loco Pilot in level 2 of pay matrix against the working post and posted to the station noted against him. His pay is fixed at Rs. 19900 in Level 2 on notional basis from the date of joining for counting the training period (except 06.03.23 to 10.04.23) for the purpose of granting increments and he is eligible for draw pay on actual basis in Level 2 from the date of regular absorption.

His appointment is subject to the following conditions.

- 1 He will be on probation for a period of two (2) years from the date of absorption as Assistant Loco Pilot and his confirmation will be subject to their satisfactory performance during the period of probation.
- 2 He is eligible to claim pay in Level 2 of pay matrix only from the date of absorption in the working post.
- 3 The intervening period from the date of completion of training and the actual absorption to the working post is treated as extension of training in terms of Rly Board's letter No. E(NG) II/57/AK/1/4 Dt 17.01.1969.
- 4 The above absorption against the working post is subject to the conditions stipulated in this office offer of Appointment issued to him at the time of his appointment as Trainee Assistant Loco Pilot
- 5 He is governed by the new restructured defined contribution pension system
- 6 The date of absorption against the working post should be advised to all concerned immediately
- 7 The request transfer registration for Inter Division/Inter Railway will be entertained after completion of 3 years on the working post in terms of GM/P/MAS Lr.No.P(S)676/II/ Transfer Policy/ASM & ALP dated 27.03.2018 & 29.03.2018.
