1. They will not seek re-transfer to their parent Division at a later date.
2. They will retain their lien in the parent railway till such time he is absorbed permanently in the new seniority unit to which they are transferred.
3. They will not be eligible for transfer privileges such as Composite Transfer Grants, Passes, and joining time as the transfer is ordered at their own request.
4. They will take their seniority in the Division/Seniority Unit to which they are transferred as per extant orders applicable for such one-way request transfer on bottom seniority in the category of Goods Train Manager in pay Matrix Level-5.
5. There is no DAR / SPE / VIG. cases pending / contemplated against them and they are not undergoing any penalty as on date.
6. They may vacate quarters, if, any occupied by them. If they wish to retain the Railway quarters as per extant rules, they have to apply to Sr. DPO/SA for retention of quarters in the old station. Retention of quarters without permission/beyond permission will attract deduction of damaged rate of rent.
7. The above-named employees may be relieved and report to this office with a proper identification memo and attested

passport-size photograph, signature, and thumb impression in terms of the Board's letter No. E(NG)I/2001/TR/16 dated 21.11.2001

8. The date of relief/joining of the employees should be advised to all concerned.
