The appointment is subject to the following terms and conditions: -

1. Their pay will be drawn from the date of assuming independent duty as Station Master at the place of posting.
2. They will be on probation for a period of TWO YEARS from the date of reporting to the regular working post as Station Master and their confirmation will be subject to their satisfactory performance during the period of probation.
3. Candidate who joined Railways after 01.01.2004 will be governed by new Restructured contributory pension system introduced by Railway Board vide letter No.F(E)II/2003/PO/2004 dated 31.12.2003 (RBE 225/2003).
4. The intervening period between the date of completion of training and the actual date of absorption is treated as extension of training in terms of Rly.Board's Lr.No.E(NG) II/56/AK/1/4 dt.17.01.1969.
5. No request transfer for Inter Divisional/Inter Railway One-way transfer will be registered prior to the completion of three years of service on the regular working post i.e., from training in terms of PBC No. 91/2019 circulated by PCPO/MAS vide Lr.No.P(R)/676/P.Vol.VI dtd.08.05.2019.
6. They will be responsible for the government Money, Goods, Stored and other properties that may be entrusted to them in the discharge of their official duties.
7. They should be prepared to serve anywhere on the Railway system.
8. In all matters, not specifically provided herein or in the recruitment's rules, they will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.
