विषय/Sub: Financial up-gradation under MACP Scheme- Ministerial Cadre of Mechanical Department-reg.

In terms of Railway Board's letter dated 25.02.2020 (RBE No.26/2020) date. 27.02.2020 as clarified vide PBC No.76/2020 dated 18.05.2020 the promotion from the post of ASM (GP Rs.2800/-) to SM (GP Rs.4200/-) may not be reckoned for the purpose of MACPs and the benefits of MACPs ignoring promotion from ASM to SM shall be admissible w.e.f.16.02.2018. Accordingly, the 2nd MACPs granted to the Level-7(GP Rs.4600/-) is treated as 1st MACPs and 3rd MACPs granted to the Level-8(GP Rs.4800) is treated as 2nd MACP and revised.

Further as per RBE No. 100/2020 dt. 24.11.2020 has clarified such employees who have progressed to other cadres by way of lateral induction/selection or due to medical de-categorization would be granted financial up gradation under MACP as per RBE No.26/2020 by ignoring their promotion/financial up gradation from ASM GP 2800/- to SM GP Rs. 4200/- irrespective of their progression in other cadres.

In view of the above, following employee ministerial staff of Mechanical Department who have fulfilled the stipulated conditions for being considered for grant of benefits under Modified Assured Career Progression Scheme (MACPS) have been found suitable by the Screening Committee for grant of 3rd financial upgradation under MACPs to the next higher Level-9 Pay Matrix (GP.Rs. 5400/- VI PC) w.e.f. 30.04.2021.

The above financial upgradation is ordered subject to all the terms and conditions as laid down in Board's letter cited and subject to the following conditions: -

01. He is free from DAR/ SPE/Vigilance cases pending / initiated / contemplated against him.

02. It will not confer on him any Seniority benefits. His names will be continued to be maintained in the original seniority

list of regular capacity and he will be considered for promotion on regular basis in the normal channel only.

03. There shall be no change in the designation, classification or higher status. However, financial and certain benefits which are linked to the pay drawn by the employee such as HBA, Allotment of Railway Accommodation shall be permitted.

4. They may exercise option within one month from the date of issue of O.O ,the fixation of pay of the above named employee and grant of next increment, will be regulated as per Rule No.13 & 10 of RS(RP) Rules -2016 issued by Rly Bd.Letter No.PC-VII/2016/RSRP/1(RBE No.90/2016) dated 27.07.2016.

a) Either their initial pay may be fixed in the higher post on the basis of Rule 1313 rule-II {FR 22(i)(a)(1)} straight away without any further review on accrual of increment in the pay scale of the lower post ID: 2023229256

(OR)

b) Their pay on promotion may be re-fixed initially at the stage on a time scale of the new post the pay in the lower post, which may be re-fixed on the basis of the provision under Rule 1313 R-II {FR 22(i)(a)(1)} on the date of accrual next increment in the scale of the lower post.

In case the employees do not exercise any option within the stipulated period it may be noted that their pay will be fixed straight away from the date of MACP as envisaged under Rule 1313 (FR 22) I(a) 1 of R,II and no further option/reversion is permissible.
