The appointment of the above named candidates is subject to the following terms and conditions:

1. His pay will be fixed on the date of reporting at the respective depot. The appointment is made on probation for two years.
2. His service is temporary and liable for termination on 14 days notice on either side except that no such notice is required, if the termination of service is due to the expiry of sanction of post he hold or on return to duty of the absentee in whose place he may be engaged in which case his service will be automatically terminated from the date of expiry of the sanction or from the date the former resumes duty as the case may be. Also no such notice will be required if the termination of service is due to his mental or physical incapacity or to his removal or dismissal as disciplinary measure after compliance with provisions of clause 2 of Article 311 of the constitution of India.
3. He will be held responsible for the charge and care of Government money, goods and stores and all other property that may be entrusted to him.
4. His continuing in service is subject to :
 - a) Qualifying for the duties prescribed for the post he hold.
 - b) Fulfilling such other general conditions of service as may be laid from time to time.
 - c) Being prepared to serve any where on Salem Division of the Southern Railway and
 - d) Compliance to all rules and regulations as applicable to their appointment.
5. He will if required be liable for Military service in the Railway Engineering units, in the territorial Army service for a period of 7 years and 8 years in the Territorial Army reserve or for such period as may be laid down in this behalf from time to time.
6. The appointment is provisional and is subject to the correctness of the scheduled caste/Scheduled Tribe/Other

Backward community certificates being verified through proper channel and if the verification reveals that the claim belong to Schedule Caste /Scheduled Tribe/other Backward Community, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false community certificates.

7. He is required to serve in field in allied or different from the one he is appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job requirement will also be altered covering different skills and fields in which he should be ready to serve; refusal to perform duty in this manner will make her liable for termination of service.

8. He will not be considered for Inter Divisional Transfer and Inter Railway Transfer before completion of required period of regular service in the working post.

9. He is covered by the National Pension Scheme as per Railway Board's letter Dt.31.12.2003 communicated under PBC NO.22/2004.

10. In all other matters not specifically provided herein or on the Recruitment Rules, he will be governed by Indian Railway Establishment Code and other extant orders issued and amended from time to time.

11. The above rank is provisional & his rank/seniority will be based on the final select list publish by Railway Recruitment Cell/Chennai.

12. His appointment is provisional subject to the outcome of character and antecedents verification.

13. The other terms and conditions stipulated in the offer of appointment quoted as reference above.
