On promotion as Chief Controller, their pay is fixed at ₹ 44,900/- with effect from the date of taking higher responsibility as Chief Controller in L-7 only, and their next date of Increment (DNI) will be 1st January 2024.

The above promotion is ordered subject to the following conditions: -

1. There is no DAR/SPE/Vig cases pending/contemplated against them and they are not undergoing any penalty debarring from promotion. If they are undergoing any penalty, they will be deemed to be carrying out their current duties only till they become free from punishment.
2. Monetary benefit of promotion will take effect from the date of shouldering higher responsibility only.
3. There is a probation period of 12 months in the promotion grade. At the end of the probation period, if the competent authority considers that the work of the railway servant during the one-year probation period on promotion has not been satisfactory or the same is needed to be watched for some time, the competent authority may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of probation, as the case may be, as stipulated in para 113 of IREM Vol. I.
4. Their pay on promotion is fixed in the revised pay structure in terms of rule 13 of RS(RP) Rules 2016 and the next increment shall accrue on the 1st day of January 2024 and thereafter it shall accrue one year on an annual basis in terms

of rule 10 of RS(RP) Rules 2016 issued vide RBE No. RBE No. 90/2016 dated 28.07.2016 & RBE No. 79/2017 dated 31.07.2017.

5. The promotion of the above-named employees should be given effect within 10 days from the date of receipt of orders as stipulated in PBC No. 114/1991. The actual date of relief and reporting for duty in promoted grade should be advised to this office promptly. If the employees are not willing to be promoted within the stipulated time, the same will be treated as the refusal of promotion and consequently, the employees will be debarred for promotion duly invoking the provision contained in Para 224 of IREM Vol. I (1989 Edition) and they will not be eligible to be considered for promotion before the expiry of one year from the date of issue of this order and they will lose place to all juniors who will be promoted in the meanwhile.

6. Any wrongful promotion / excess payment detected subsequently will be subject to rectification and recovery in terms of PCPO/MAS letter No. P(S) 353/ Court/Policy/Vol. II dated 17.10.2017 (PBC No. 184/2017).

7. The above promotions are provisional and subject to the outcome of the main SLP and the Contempt petition No.314/2016 in SLP (C) No.4831/2012 in terms of RBE No.117/2016 dated 30.09.2016 and in terms of RBE No.91/2018
