The Technical resignation is ordered subject to the following conditions:-

- 1.She has to submit a fresh bond to serve the new employer for the remaining service in the new employer department/organization.
- 2 The new department/organization on obtaining the fresh bond, binding him to serve them for the balance of the original bond period, and in case he fails to serve the new department/organization, or leaves it before completion of the original bond period, for a job, where exemption from bond obligation is not available, the proportionate bond money should be realized from the individual and refunded to the Railway Administration, with whom he had originally executed a bond. The Ministry/Department/Organization, where the person is new employed, should also duly intimate the original Ministry/Department/Organization, the fact of a fresh bond having been executed by the person concerned.
- 3 . Date of joining in the new Department should be advised.
- 4 . She is free from DAR/SPE/Vigilance cases.
- 5 She has to hand over the Railway Materials entrusted to his charge.
6. She has to vacate Railway Quarters, if in occupation. Retention of Railway Quarters beyond the period for which permission has been granted on her application will be treated as unauthorized occupation.
