The above promotions are ordered subject to the following conditions:

1. Regular promotion orders considering the existing transfer requests will follow.
2. That there are no D&AR/SPE/Vig. Cases pending/contemplated against him and he is not undergoing any penalty debarring him for promotion.
3. The promotion ordered in favour of the above employees will take effect from the date of shouldering higher responsibilities.
4. He will be on probation for a period of one year from the date of promotion to higher grade under Rule 113 of Chapter-I Section F of IREM (1989 Edition).his promotion is subject to review at the end of the probationary period and if found to be satisfactory they will be deemed to be confirmed in the higher promotional grade.
5. He is allowed to exercise option within a period of one month for fixation of pay in terms of proviso under Rule 1313 FR 22 (I) a(1) of R-II and PBC No.308/2019 dated:07.01.2020 In case the employees do not exercise any option within the stipulated period, it may be noted that their pay will be fixed as envisaged under Rule 1313 FR 22 (I) a (1) of R-II and no further option (revision) is permissible as envisaged in Railway Board's letter No.PC VII/2017/R-1/7 dated 18.12.2019 (RBE. No.212/2019).

6. In case where financial up gradation under MACP scheme already granted and pay fixed accordingly no further pay fixation will arise at the time of regular promotion. If the level in the Pay Matrix at the time of financial upgradation under MACPs is different from what is available in the normal hierarchy at the time of regular promotion in one's own AVC, then the higher level in the Pay Matrix attached to the next promotion post in the hierarchy of the concerned cadre/organization will be fixed only at the time of regular promotion, in terms of RBE No.155/2016 dt.19.12.2016.

7. In terms of Board's letter No.2018-E(SCT)I/25/9 dated 03.06.2019 (PBC No.141/2019), the promotion ordered above are purely provisional and subject to the final outcome of on-going litigations / court cases on the subject.

8. The actual date of assuming higher responsibilities should be advised to this office.
