Shri.A.Saravanan, Ex.Tech.II/Sig/RASP , Emp.No.15650601192 was awarded the penalty of removal from Railway service w.e.f.03.12.2021 due to unauthorized absence from duty on various dates during the year 2020 failure to maintain devotion to duty and behaved in a way quite unbecoming of a Railway Servant vide reference(1) quoted.

On submission of appeal, ADRM/SA & the Appellate Authority has modified the penalty as under:

“Shri.A.Saravanan, Ex.Tech.II/Sig/RASP is reinstated in Railway service as “reduction from the present post and grade to post and grade in Level-02 with pay as Rs.23800/- with effect from service restoration for a period of two years with effect of postponing future increments of pay with lowest seniority in the grade.”

On having medically found fit in “BEE-ONE with glasses” vide medical certificate No.651853 Dt.21.06.2023 issued by DMO/RH/ED, Shri.A.Saravanan is reinstated in Railway service as Tech.III/Signal on pay of Rs.23800/- in Level-2 of Pay Matrix and posted at MTDM under the control of SSE/Sig/SA .

The reinstatement of the above named employee is subject to the following terms and conditions:

- 1) He is reinstated in Railway Services on pay of Rs.23800/- in Pay Matrix Level-2 for a period of two years with effect from restoration of service with the effect of postponing future increments of pay with loss of seniority.
- 2) The intervening period from the date of removal from service and the date of resumption for duty will be treated as “**Dies non**”.
