1. 2. He will not seek re-transfer to their parent Unit/Railway at a later date.
3. He is not eligible for any transfer benefits on transfer account as the transfers are agreed at his own request.
4. He will retain his lien in the Parent Departments seniority unit until he is permanently absorbed in the new seniority unit to which he is posted.
5. He should be free from DAR/SPE/Vig cases as on date of his relief.
6. He may vacate quarters if, any occupied by him. If he wishes to retain the quarters as per extant rules, he has to apply to Sr.DPO/SA for retention of quarters in the old station. Retention of quarters without permission/beyond permission will attract deduction of damaged rate of rent.
7. In terms of Railway Board's letter No.E(NG)-1/2006/TR/6 dated 21.04.2006 (RBE No: 53/2006), no request for back tracking from the above employees from the mutual exchange will be entertained in any circumstances.
8. Shri Rahul L Assistant/C&W/MAS may be relieved with proper identification Memo and attested passport size photograph, signature and thumb impression to report to Sr.DPO/O/SA in terms of instructions contained in Railway

Board`s letter No.E(NG)1-2001/TR-16 Dated 21.11.2001.

9. The employee may be relieved in terms of instructions contained in Railway Board`s letter No.E(NG)1-2007/TR/26 dated 04.12.2007. The date of relief/joining of the employee may be advised to all concerned.
