He should vacate Railway Quarters if in occupation by him as per extant orders. Retention of Railway Quarters beyond the permitted period will be treated as unauthorized occupation and the following course of action will be taken against him.

1. Cancellation of allotment and eviction proceeding
2. Recovery of damage rate of rent as per rules
3. Withholding of Post Retirement passes at the rate of one set for every month of unauthorized occupation for more than Ten days will be taken as a full month

4. The entire amount of DCRG will be withheld for non-vacation of Railway Quarters beyond the date of Voluntary Retirement

He will not be permitted to withdraw his request for Voluntary Retirement under any circumstances at a later date. He has to obtain the Pension Forms from Ch.OS/Settlement/PB/SA and submit the same duly filled up in all respects, for arranging settlement dues.
