The appointment of the above named candidates are subject to the following terms and conditions:

1. Their pay will be fixed on the date of reporting in the respective P.Way section/units. The appointment is made on probation for two years.
2. They must clearly understand that the appointment is terminable on 14 days notice on either side except that no such notice is required, if the termination of service is due to the expiry of sanction of post they holds or on return of the absentee in whose place they may engaged in which case their service will be automatically terminated from the date of expiry of the sanction or from the date the former resumes duty as the case may be. Also no such notice will be required if the termination of service is due to their mental or physical incapacity or to their removal or dismissal as disciplinary measure after compliance with provisions of clause 2 of Article 311 of the constitution of India.
3. They will be held responsible for the charge and care of Government money, goods and stores and all other property that may be entrusted to them.
4. Their continuing in service is subject to:

- a) Qualifying for the duties prescribed for the post they holds.
- b) Fulfilling such other general conditions of service as may be laid down from time to time.
- c) Being prepared to serve anywhere on Salem Division of the Southern Railway and
- d) Compliance to all rules and regulations as applicable to their appointment.

5. They will if so required be liable for Military service in the Railway Engineering units, in the territorial Army service for a period of 7 years and 8 years in the Territorial Army reserve or for such period as may be laid down in this behalf from time to time.

6. The appointment is provisional and is subject to the correctness of the Scheduled Caste/Scheduled Tribe/Other Backward Community certificates being verified through proper channel and if the verification reveals that the claim belong to Scheduled Caste/Scheduled Tribe/Other Backward Community, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false community certificates.

7. The appointment is provisional and is subject to the income and asset certificate being verified through the proper channel and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith assigning any further and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of fake/false certificate.

8. They are required to serve in field in allied or different from the one they are appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job requirement will also be alerted covering different skills and fields in which he should be ready to serve; refusal to perform duty in this manner will make them liable for termination of service.

9. They will not be considered for Inter Divisional Transfer and Inter Railway Transfer before completion of required period of regular service in the working post.

10. They are covered by the National Pension Scheme as per Railway Board's letter Dt.31.12.2003 communicated under PBC No.22/2004.

11. In all other matters not specified provided herein or on the Recruitment Rules, they will be governed by Indian Railway Establishment Code and other extant orders issued and amended from time to time.

12. The above rank is provisional and their rank/seniority will be based on the final select list publish by Railway Recruitment Cell/Chennai.

13. Their appointment is provisional and subject to verification of character and antecedents and in the case of any adverse report received later on their services will be terminated.

14. No Travelling (Daily) Allowance will be granted for joining the post.

15. The other terms and conditions stipulated in the offer of appointment quoted as reference above stands good.
