The above Promotion is ordered subject to the following conditions.

- The promotion of SL.No.1 will take effect from the date of assuming higher responsibility. The promotion of SL.No.2 to 5 will take effect on or after 24.08.2023 and promotion of SL.No. 6 & 7 will take effect on or after 27.08.2023
- They are free from DAR/SPE/Vigilance cases.
- There is a probation period of 12 months in the promotion grade. At the end of the probation period, if the appointing authority considers that the work of the railway servant during the one-year probation period on promotion has not been satisfactory, or the same is needed to be watched for some time, they may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of probation, as the case may be, as stipulated in Para.113 of IREM Vol. I.
- They are not placed under suspension and no departmental/criminal proceedings etc., is pending against them. or they are not undergoing any penalty debarring them from Promotion, which should be ensured by the Supervisor before implementing the orders.
- They may exercise option for the fixation of pay as under:
 - either initial pay may be fixed in the higher post on the basis of Rule 1313 R.II (FR 22) (I)(a) (1) straightaway without any further review on accrual of increment in the pay scale of the lower post.
 OR
 - Pay on promotion may be fixed initially at the stage on a time scale of the new post above the pay in the lower post, which may be re-fixed on the basis of the provision under Rule 1313 R.II (FR 22) (I) (a) (1) on the date of accrual of next increment in the scale of the lower post.
- In case the employees do not exercise any option within the stipulated period it may be noted that their pay will be fixed as at 5(i)above.
- "The above selection/promotion has been initiated/ordered only after ascertaining quantifiable data of representation of SC and ST employees in the grade, as per the post-based rosters, against roster points. Accordingly, the above promotion order is issued in compliance with the directions of the Hon'ble Supreme Court in Nagaraj case".
- The above Promotion is provisional subject to outcome of the main SLP and the Contempt Petition No.314/2016 in SLP(C) No.4831/2012 in terms of RBE No..117/2016 dated 30.09.2016 and in terms of RBE No.91/2018 dated.15.06.2018.
- If pay has already been fixed on financial up gradation under MACP scheme, there is no pay fixation benefits on promotion.
- The above promotion is provisional and subject to the outcome of pending court cases/litigation.
