Having accepted the terms and conditions stipulated in the offer of appointment issued by this office letter No:SA/P.268/III/Comml./RRB/342920 dt: 26.07.2023, the under-mentioned RRB candidate, is appointed as Pro. Sr.Commercial-cum-Ticket Clerk in Group 'C' Service in Commercial Department of SA Division on stipendary pay Rs.29,200/- in PML-5 plus DA under the rules in force from time to time and he is directed to attend the initial training course for Pro.CCTC at MDZTI/TPJ from 22.08.2023 to 20.10.2023.

He is appointment is subject to the following terms and conditions: -

1. His appointment is provisional and subject to verification of character and antecedents. In case of character & antecedents of the candidate is found not verified or any false information is given by the candidate in their self-declaration, the provisional appointment orders will be cancelled forthwith, and other criminal / legal action will also be taken as consequence.
2. He should attend the prescribed training for Pro Sr.CCTC at MDZTI/TPJ and should join the course in proper uniform. If he does not complete the course successfully, OBC/UR/EWS candidates may be allowed a second chance without stipend and SC/ST candidate may be allowed a second chance with stipend if considered necessary by the administration as per extant rules and if failed to qualify in the repeat course also, there services will be terminated.
3. His appointment is provisional and is subject to the correctness of the scheduled caste/scheduled Tribe/Other Backward Community certificate being verified through proper channel and if the verification reveals that the claim belong to Schedule Caste /Scheduled Tribe/other Backward Community, as the case may be, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false community certificate.
4. His appointment is provisional and is subject to the income and asset certificate being verified through the proper channel and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith assigning any further reasons and without prejudice to such further action as may be taken under the provisions

of the Indian Penal Code for production of fake/false certificate.

5. In terms of Railway Board letter No.PC-V/2016/PS/I(Stipend) dated 16.09.2020 (RBE No.80/2020) circulated vide PBC No.160/2020 dated 17.09.2020 during the training period they will be allowed to draw the monthly stipend of Rs.29,200/- in PML-5.

6. He will be absorbed as Sr.Commercial-cum-Ticket Clerk only on successful completion of the initial training course on pay Rs.29,200/- in PML-5. He will be on probation for a period of TWO YEARS from the date of reporting to the regular working post as Sr.CCTC and his confirmation will be subject to his satisfactory performance during the period of probation.

7. Candidate who joined Railways after 01.01.2004 will be governed by new Restructured defined contribution pension scheme introduced by Railway Board vide letter No.F(E)III/2003/PNI/24 dated 31.12.2003 (RBE 225/2003).

8. He will be responsible for the government Money, Goods, Stores and other properties that may be entrusted to his in the discharge of their official duties.

9. He should be prepared to serve anywhere on the Railway system.

10. The merit order indicated above is temporary.

11. In all matters, not specifically provided herein or in the recruitment's rules, they will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.

12. Seniority will be assigned as per para 303 (a) and para 304 of Indian Railway Establishment Manual Vol-I.
