The under mentioned candidate has been selected for appointment through RRC/MAS (CEN No. 01/2019) as Assistant/Electrical Loco Shed in Electrical TRS Department in Pay Matrix Level 01 vide reference 1. Having accepted the offer of appointment issued vide this office Letter under reference 2, on the terms and conditions for such appointment, he is appointed as Assistant/Electrical Loco Shed in Electrical TRS Department, Salem Division on Pay Rs. 18,000/- in Pay Matrix Level-01 in VII PC plus other allowances admissible under rules from time to time. He is charged against PwBD quota and found fit in PwBD - VI (VH-LV (low vision)) as certified by CMS/TVC vide MC No. 184194290004954ABRAHAM dtd 01.03.2023.

The appointment of the candidate is subject to the following terms and conditions:

1) He must clearly understand that the appointment is terminable on 14 days notice on either side, except that no such notice is required if the termination of service is due to the expiry of sanction to the post he holds or on return duty of the absentee in whose place he maybe engaged, in which case his service will be automatically terminated from the date of expiry of the sanction or from the date the former resumes duty, as the case maybe, also no such notice will be required if the termination of service is due to the mental or physical incapacity or to his removable or dismissal as a disciplinary measure after compliance with the provisions of clause (2) of Article 311 of the constitution of India.

2) He will be held responsible for the charge and care of Government money, goods and stores and all other property that maybe entrusted to him.

3) His continuing of service is subject to:

- Qualifying for the duties prescribed for the post he holds.
- Fulfilling such other general conditions of service as maybe laid from time to time.
- Being prepared to serve anywhere in Salem Division of Southern Railway and
- Compliance to all rules and regulations as applicable to his appointment.

4) He will if so required be liable for Military Service in the Railway Engineering units, in the territorial Army service for a period of 7 years and 8 years in the Territorial Army reserve or for such period as maybe laid down in this behalf from

time to time.

- 5) The appointment is provisional and is subject to the genuineness of the Schedule Caste/Schedule Tribe/Other Backward Community certificates being verified through proper channel and if the verification reveals that the claim belongs to Schedule Caste/Schedule Tribe/Other Backward Community, as the case maybe, is false, the service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as maybe taken under the Provisions of the Indian Penal Code for production of false community certificates.
- 6) He is required to serve in field in allied or different from the one he is appointed and for this purpose necessary training will also be imparted. Till such time, in the exigencies of service, the job recruitment will also be alerted covering different skills and fields in which he should be ready to serve; refusal to perform duty in this manner will make him liable for termination of service.
- 7) The appointment is provisional and is subject to the income and asset certificate being verified through the proper channel and if the verification reveals that the claim to belong to EWS is fake/false the services will be terminated forthwith assigning any further reasons and without prejudice to such further action as maybe taken under the Provisions of the Indian Penal Code for production of fake/false community certificates.
- 8) He will not be considered for Inter Divisional Transfer and Inter Railway Transfer before completion of required period of regular service in the working post.
- 9) He is covered by the National Pension Scheme as per Railway Board's Letter dated 31.12.2003 communicated under PBC No. 22/2004.
- 10) In all other matters not specifically provided herein or on the Recruitment Rules, he will be governed by Indian Railway Establishment Code and other extant orders issued and amended from time to time.
- 11) As the merit order indicated above is temporary, the seniority will be assigned later based on final merit order to be issued by RRB/RRC.
- 12) His appointment is provisional subject to the outcome of character and antecedents verification and the other terms and conditions stipulated in the offer of appointment quoted as in reference above.
