1. 4. They should be free from DAR/SPE/Vig cases as on date of their relief.

5. He may vacate quarters, if, any occupied by him. If he wishes h to retain the quarters as per extant rules, he has to apply to Sr.DPO/SA for retention of quarters in the old station. Retention of quarters without permission/beyond permission will attract deduction of damaged rate of rent.
