The transfer & posting of above-named employees are subject to the following conditions: -

1. The lien of the above employee will be continued to be maintained in her parent unit and she is liable for repatriation to her parent unit at any time on administrative grounds, if her performance is not satisfactory.
2. She can be transferred to work in other construction units also, if the work in the particular construction unit is completed or reduced, with the CAO's approval. CAO/Construction is vested with full powers to transfer her within any one of the Construction Units due to exigencies and in case, if she is not willing, she can be repatriated to their parent unit.
3. In terms of PBC No.164/2010 circulated under P(R)676/Policy/CN/RE dated 12-11-2010, the employee posted should be repatriated to his/her parent unit at least one year prior to his/her date of retirement.
4. She should be free from DAR/SPE/Vig. cases at the time of her relief from the present post concerned supervisors please insured.
5. She is eligible for transfer benefits privileges provided change of address is involved on the transfer and subject to fulfilling the conditions of Board's orders issued vide RBE No.76/2011 dated 26-05- 2011 with reference to payment of composite transfer grant.
6. The relieving memorandum/order sparing the employee should have the photograph of the employee pasted on it and also have the specimen signature of the transferred employee and his/her left thumb impression both of which duly attested by the Officer signing the memorandum/order with his/her name and designation appearing below the signature

as stipulated in Railway Board's letter No.E(NG)1- 2001/TR-16 dt. 21-11-2011.
