  - 2) There is no D&AR/SPE./Vig cases pending/contemplated against him and he is not undergoing any effective penalty of withholding of increment/reduction of pay on the cut off date i.e 01.12.2022
  - 3) There shall be no change in the nomenclature /designation, duties and responsibilities and classification of the posts after upgradation and he will remain classified as Group 'C'
  - 4) The above upgradation has to be counted as offset against the financial upgradation against under MACPs in terms of extant instructions for regulations of MACPs.
  - 5) In case where financial upgradation under ACP/MACP scheme already granted and pay fixed accordingly no further pay fixation will arise.
  - 6) He is allowed to exercise option within a period of one month for fixation of pay in terms of provision under Rule 1313 FR 22(1) a (1) of R-II and PBC No.308/2019 Dt.07.01.2020. In case, the employee do not exercise any option within the stipulated period, it may be noted that his pay will be fixed as envisaged under Rule 1313 FR 22 (1) a (1) of R-II and no further option (Revision) permissible as envisaged in Railway Board's letter No.PC VII/2016/1/6/2 Dt.31.07.2017 (PBC No.115/2017)
  - 7) In terms of Board's letter No.2018-E(SCT)1/25/9 Dt.03.06.2019 (PBC No.141/2019), the above upgradation ordered above are purely provisional and subject to the final outcome of ongoing litigations/court cases.
