She is directed to attend the initial training course for Pro.CCTC at MDZTI/TPJ commencing from 25.10.2023 to 21.12.2023.

The appointment is subject to the following terms and conditions:-

1. She should attend the prescribed training for Pro.CCTC at MDZTI/TPJ and should join the course in proper uniform. If she do not complete the course successfully, OBC/UR candidates may be allowed a second change without stipend and SC candidates may be allowed a second chance with stipend, as per extant rules and if failed to qualify in the repeat course also, her services will be terminated.
2. In terms of Railway Board letter No.PC-V/2016/PS/I(Stipend) dated 16.09.2020 (RBE No.80/2020) circulated vide PBC No.160/2020 dated 17.09.2020 during the training period she will be allowed to draw the monthly stipend of Rs.21,700/- in PML-3.
3. She will be absorbed as Commercial-cum-Ticket Clerk only on successful completion of the initial training course on pay Rs.21700/- in PML – 3.
4. She will be on probation for a period of TWO YEARS from the date of reporting to the regular working post as CCTC and her confirmation will be subject to her satisfactory performance during the period of probation.
5. Candidates who joined Railways after 01.01.2004 will be governed by new Restructured defined contribution pension scheme introduced by Railway Board vide letter No.F(E)III/2003/PNI/24 dated 31.12.2003 (RBE 225/2003).
6. She will be responsible for the government Money, Goods, Stores and other properties that may be entrusted to her in the discharge of her official duties.

7. She should be prepared to serve anywhere on the Railway system.

8. In all matters, not specifically provided herein or in the recruitment's rules, she will be governed by the provisions of Indian Railway codes and other extant orders as amended and issued from time to time.

9. Seniority will be assigned as per para 303 (a) and para 304 of Indian Railway Establishment Manual Vol-I.
