He should vacate Railway quarters if any in occupation as per extent orders. Retention of Railway quarters beyond the permitted period will be treated as unauthorized occupation and the following course of action will be taken against him.

- Cancellation of allotment and eviction proceeding.
- Recovery of Damage rate of rent as per rules.
- Forfeiture of one set of post retirement complementary pass for every month of unauthorized retention of Rly. Qrs in terms of Railway Board's letter No.E(G)81/Qrs/5 dt.04.06.1994.
- The entire amount of DCRG will be with held for non-vacation of Railway quarters beyond the date of voluntary retirement.

He shall open necessary bank account for drawl of pension and other benefits. He should also obtain settlement forms and hand over the same duly filled in within a fortnight from the date of issue of this office order.
The qualifying service of Shri.M.ANBURAM is 37 years 04months and 17 days and it is certified by Sr.DFM/SA Lr.No. P.500/Sr.DFM/SA/PEN/Correspondence dated 23.08.2023.
He will not be permitted to withdraw his request for voluntary retirement under any circumstances at a later date.
