1. They are free from DAR/SPE/Vigilance cases pending/initiated/contemplated against him.
2. It will not confer on them any seniority benefits. Their name will be continued to be maintained in the original seniority list of regular capacity and they will be considered for promotion on regular basis in the normal channel only.
3. There shall be no change in the designation, classification or higher status. However, financial and certain other benefits which are linked to the pay drawn by the employees such as HBA, allotment of Railway accommodation shall be permitted.
4. The pay on promotion shall be fixed in the revised pay structure in terms of Rule 13 of RS (RP) Rules 2016 and next increment shall accrue on the 1st day of July 2022/2023 as the case may be and thereafter it shall accrue one year on annual basis in terms of Rule 10 of RS (RP) Rules 2016 issued under Rly Boards Letter No. PC-VII/2016/RSRP/1 dated 28.07.2016 (RBE No.90/2016). They may exercise option within one month from the date of promotion to fix their pay either from the date of promotion or from the date of next increment under Rule 1313 (FR22) I (a) 1 of R.II in terms of RBE 79/2017.
5. In case the employees do not exercise any option within the stipulated period it may be noted that their pay fixed in the above table is stands good and no further option/revision is permissible.
