One post of Senior Translator/Hindi/S.Rly in Pay Matrix Level-7 of Salem Division is temporarily transferred to Sr.DEE/RS/LS/O/ED.

Shri. Mohan, Junior Translator/Sr.DEE/RS/LS/O/ED in Pay Matrix Level-6 (Grade Pay Rs.4200/-) who has been found suitable for promotion to the post of Senior Translator/Hindi/S.Rly in Pay Matrix Level-7 (GP.Rs.4600/-) and placed in the select list vide reference cited above, is provisionally promoted as Senior Translator in Pay Matrix Level - 7 against the existing vacancy and retained in Sr.DEE/RS/LS/O/ED against the transferred post from Salem Division vide ref (I) above.

He is advised to look after entire ED along with Electrical Loco Shed. Having been placed in the Select List for the post of Senior Translator, the following Junior Translator PM Level – 6 in 7th PC is promoted as Senior Translator in PM Level 7 in 7th PC in General Department and retained in same station at Sr.DME/DSL/O/ED, SA Division with immediate effect

The above Promotion is ordered subject to the following terms and conditions:

1) The controlling Office should ensure that there are no prima face cases (DAR/VIG/SPE) pending against him as a result of fact-finding enquiry or otherwise and that he is not placed under suspension or departmental proceedings initiated against him and he is not undergoing any penalty debarring him from promotion.

2) The promotion of the employees to the higher grade will take effect only from the date of shouldering higher responsibilities after ensuring that he is free from DAR/Vig cases.

3) In case they are unwilling to take up the promotion order, the same should be reported to this office immediately along with a letter from the employees to the effect that they are unwilling for promotion so as to debar them from promotion as per provisions contained in Rule 224-I of IREM.

4) Consequent to the Promotion to higher grades, the duties/higher responsibilities to the employee may be allocated by the Controlling Officer.

5) The employee promoted will be on probation for a period of 12 months from the date of shouldering higher responsibility in the promoted grade. Continuance of Promote in the promoted grade will depend on his performance and successful completion of probation period as per Para 113 of IREM & Rly Boards letter No. dated 02-08-2001 (RBE No.148/2001 & PBC No.135/2001). Non completion of probation period in the promoted grade if the promote seeks transfer to the post from which he was promoted, his pay in lower grade/post on such reversion will be fixed at a stage what they should have drawn had they have not been promoted.

6) If employees already placed in higher level under MACP Scheme, they are not entitled for further fixation of pay on promotion as Ch.OS.

7) The promotion has been ordered after ascertaining quantifiable data of representation of SC and ST employees in the grade, as per the PBR.

8) The above promotion is subject to outcome of the judgement of the five judges Bench of the Hon'ble Supreme Court dated 26-09-2018 in SLP(Civil) No.30621 of 2011 which was issued in terms of Board's letter No.2018-E(SCT)I/25/9 dated 03-06-2019 (PBC No.141/2019 dated 08- 07-2019).

9) The above promotion will take effect from the date of assuming higher responsibility. and advised to all concerned without fail.
