3. There shall be no change in the designation, classification or higher status. However, financial and certain benefits which are linked to the pay down by the employee such as HBA, Allotment of Railway Accommodation shall be permitted.
4. She is allowed to exercise option for fixation of pay within one month from the date of issue of this O.O. The pay on MACP shall be fixed in the revised pay structure in terms of Rule 13 of RS(RP) Rules 2016 and next ID: 2023197677 increment shall accrue on the 1st day of July/January as the case may be and thereafter it shall accrue one year on annual basis in terms of Rule 10 of RS(RP) Rules 2016 issued under Rly Boards Letter No. PC-VII/2016/RSRP/1 dated 28.07.2016 (RBE No.90/2016).They may exercise option within one month from the date of issue of O.O to fix their pay either from the date of MACP or from the date of next increment under Rule 1313 (FR22)I(a)1 of R.II in terms of RBE 79/2017.

In case the employee does not exercise any option within the stipulated period it may be noted that her pay will be fixed straight away from the date of MACP as envisaged under Rule 1313 (FR 22) I(a) 1 of R,II and no further option/reversion is permissible.
