The above Promotion is ordered subject to the following conditions:

1. They are free from DAR/SPE/Vigilance cases.
2. There is a probation period of 12 months in the promotion grade. At the end of the probation period, if the appointing authority considers that the work of the railway servant during the one year probation period on promotion has not been satisfactory, or the same is needed to be watched for some time, he may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of probation, as the case may be, as stipulated in Para.113 of IREM Vol. I.
3. They are not placed under suspension and no departmental/criminal proceedings etc., is pending against them or they are not undergoing any penalty debarring them from promotion, which should be ensured by the Supervisor before

implementing the orders.

4. The above selection/promotion has been initiated/ordered only after ascertaining quantifiable data of representation of SC and ST employees in the grade, as per the post based rosters, against roster point mentioned against each. Accordingly promotion orders are issued in compliance with the directions of the Hon'ble Supreme Court in M.Nagaraj case.

5. In terms of RBE 117/2016, the promotions are provisional and subject to the outcome of SLP(C) No.4831/2012 filed by Hon'ble Supreme court of India.

6. They may exercise option for fixation of pay as per Railway Board's letter No.PC VII/2016/1/6/2 Dt.31.07.2017(RBE 79/2017) (PBC 115/2017) within one month. In case they not exercise option within one month from the date of shouldering higher responsibilities their pay will be fixed straight away.

7. The promotion is provisional and subject to the outcome of the pending SLP's(C) No. 30621/2011, 31288/2017 and 28306/2017 –filled before the Hon'ble Supreme Court.

8. If pay fixation already done consequent on financial up gradation under MACP scheme, there is no pay fixation to the employee.

9. The above promotion is provisional and subject to the outcome of pending court cases/litigation.

10. The above promotion will take effect from assuming higher responsibility.
