The above promotions are ordered subject to the following conditions:-

1. There is no DAR / SPE / VIG. cases pending / contemplated against them and they are not undergoing any penalty debarring them from promotion. If anyone is undergoing any penalty, they will be deemed to be carrying out their current duties only till they become free from punishment.
2. There is probation period of 12 months in the promotion grade. At the end of the probation period, if the competent authority considers that the work of the Railway servant during the one year probation period on promotion has not been satisfactory or the same is needed to be watched for some time, the competent authority may revert the concerned employee to the post or grade from which the employee was promoted or extend the period of probation, as the case may be, as stipulated in Para 113 of IREM Vol.I.
3. The promotes shall carry out their promotion within 10 days, from the receipt of this order and failure to do this will be treated as refusal of promotion and consequently they will not be eligible to be considered for promotion before the expiry of one year debarment period and they will lose seniority to all their juniors promoted in the mean while.
4. The promotion will take effect from the date of shouldering higher responsibility.

5. The benefit of pay fixation from one post to another post on promotion within the same pay band carrying same identical grade pay from Sr. Goods Train Manager to Sr. Passenger Train Manager is not admissible under Rule 13 pf (RS) Rules 2008 (Ref: RBE 54/2014 dated 22.05.2014).

6. The above promotions are provisional and subject to the outcome of pending court cases /litigations.
