The absorption of the above Trainee as JE/ELS/ED against the regular working post of JE/ELS/ED is subject to the following conditions.

- 1) On absorption against the regular working post as JE/ELS/ED in Pay Matrix Level 06, he will be on probation for a period of two years from the date of absorption. The intervening period from the date of completion of Apprenticeship/training period to the date of actual absorption of the regular working post is treated as extended period of Apprenticeship as per the Railway Bd's letter No.E(NG)1167/AG1/4 dated 17.01.1969.
- 2) In terms of Rly Bd's letter No.2004/AC-II/21/1 dated 10.02.2004; He is coming under CONTRIBUTORY PENSION. All the NEW recruits in the Central Government Service, joining the Government service with effect from 01.01.2004 shall compulsorily make a contribution to the government. The contribution payable by the Railway servants towards the ID: 2022109767 system under Tier-I will be recovered at the rate of 10% of basic pay and DA from salary every month. In addition to the above pension account each Government servant may also have Tier-II with draw able account at their option.
- 3) He is eligible to claim pay in Pay Matrix level 06 only from the date he assumes regular working post.
- 4) His appointment as JE/ELS/ED will be subject to other conditions as stipulated in the offer of appointment as Trainee JE/ELS/ED.
- 5) The date of joining as JE/ELS/ED on absorption may be advised to all concerned.
- 6) As per IREM Vol I chapter 3 Para 303 Candidates who are sent for initial training to Training schools will rank in

Seniority in the relevant Grade in the order of merit obtained in the examination held at the end of the training period before being posted against working post. Hence their seniority will assign accordingly.
