1. Quotations should be dropped in the box, which is available in the office of Senior Divisional Commercial Manager, Tiruchchirappalli Jn, Southern Railway only, Applications send through other means will not be accepted.
2. Quotations should be signed by the bidder along with date.
3. The **rate** should be quoted for per day both in figures and words. In case of difference in both, rates quoted in words will be treated as final.
4. There should be no erasures/overwriting on the quotations, which shall attract rejection.
5. The applicant should furnish any of the documents with photo as proof of identity for address such as PAN CARD, Passport, Voter ID Card, Driving License, Bank Pass Book or Ration Card.

6. The successful applicant should remit electrical energy charges as advised by the Railways for the consumption of electrical energy.
7. In the event of being considered as successful applicant, **he/she should pay the 180 days licence fee in advance in one instalment to the station manager prior to taking up the parking lot.**
8. The applicant (in his name) should submit security deposit to the tune of 5% of the amount quoted for **180 days** in the form of Demand Draft drawn in favour of Sr. Divisional Finance Manager, Southern Railway, Tiruchchirappalli.
9. **The SD amount will be refunded only on successful completion of quotation period. In case of withdrawal the SD amount will be forfeited.**
10. Application without SD will not be considered. The SD paid by the unsuccessful bidder will be refunded.
11. Proper accountal and remittance of GST to be done by the licensee. GST@18% on L.Fee to be paid along with Advance License Fee
