- 3 No change of category will be permitted for a minimum period of three years unless she is not medically suitable for the post she is appointed.
- 4 She is not eligible for Inter Divisional Transfer before completion of three years of regular service from the date of their Appointment.
- 5 She should be prepared to serve anywhere in Madurai Division.
- 6 It must be clearly understood that her employment is temporary and that her services may be terminated at any time without notice, if such termination is due to expiry of the officiating vacancy in which she is appointed or due to her removal or dismissal as a disciplinary measure after compliance with the provision of clause(2) of Article 311 of the constitution of India.
- 7 The appointing authority however, reserves the right of terminating their services, forthwith or before the expiry of the stipulated period of notice by making payment to them or the sum equivalent to pay & allowance for the period of notice or the unexpired portion thereof. She should not resign or quit her employment except with the previous consent in writing of the Head of the Department or office in which she is employed.
- 8 In all matters not specifically provided for herein or in the recruitment rules, she will be governed by provision of the Indian Rly. Establishment Codes and other extant orders as amended and issued from time to time.
