Sub: Inter Railway one-way request transfer of Shri Santhosh Kumar (ST)TTI(SL)MDU of MDU Division to Katikar Division of North Frontier Railway.

CPO/MAS has accorded approval for the Inter Railway one-way request transfer of Shri Santhosh Kumar, (ST) TTI(SL)MDU of Madurai Division in Pay Band Rs.9300-34800 with Grade Pay Rs.4200/- to Katikar Division of North Frontier Railway on reversion as TE in Pay Band Rs.5200-20200 in Grade Pay Rs.1900/- on bottom seniority, subject to the following conditions governing such transfer.

The above transfer is ordered subject to the following conditions.

1. He will rank junior most to all permanent/officiating and temporary TEs in Pay Band of Rs.5200-20200 and Grade pay Rs.1900/- in Katikar Division of North Frontier Railway on the date of his joining the new seniority unit.
2. He will not seek retransfer to his parent unit/Railway at a later date.
3. He will not be eligible for composite transfer grant/transfer pass, joining time etc., since the transfer is ordered at his request.
4. There are no DAR/SPE/Vigilance cases pending against him on the date of relief.
5. The relieving Memorandum/Order sparing the employee should have the photograph of the employee pasted on it duly attested in the manner viz., the rubber stamp should clearly indicate the name and designation of the Supervisor/Officer. The Memorandum/Order should also have the signature of transferred employee and his left thumb impression both of which should be duly attest by the Officer signing the memorandum/Order with his name and designation appearing below the signature as stipulated in Railway Board's letter No.E(NG)I-2001/TR/16 dated 21.11.2001 (RBE No.229/2001)
6. The date of relief and date of joining the new Railway may be advised to this office.
