विषय/Sub: Appointment of Tech.III/TRD against Compassionate Ground.

संदर्भ/Ref: This Office's offer of appointment issued vide No.U/P. 536/VII/Appt.Gr.C. dt. 19.09.14.

Shri.V. Venkateshwaran, S/O. Shri.P. Venkatachalapathy, M.V.Driver, Mechl. Br/MDU (Died on 22.12.2013) who is eligible for appointment in Group C service as Technician III in Pay Band 5200-20200 (1900 Grade Pay) on compassionate Ground is now appointed as Appren. Technician Gr.III/Electrical/TRD in stipend 5200+1800 (one increment in 2<sup>nd</sup> & 3<sup>rd</sup> year) has to under go 36 months prescribed training from the date of joining for training. The first posting will be done after the successful completion of the training. He is directed to report TRD VPT depot under SSE/TRD/VPT for training.

His appointment is subject to the following terms and conditions:-

1. He should undergo the prescribed training and pass successfully. If he does not complete the same successfully, he is eligible for a second chance without stipend if considered necessary the administration. If he fails in the initial training and also in the repeated course, he will be discharged from service.
2. He will be on probation for a period of 2 years and his confirmation will be subject to the satisfactory performance during the period of probation. After successful completion of training. He will be absorbed as Technician Gr.III in Electrical Department/TRD in Pay band Rs.5200-20200 with Grade Pay Rs.1900/- plus usual allowances admissible under the Rules in force from time to time.
3. He will be responsible for the Government money, goods stores and other property that may be entrusted to his care in the discharge of his official duties.
4. No change of category/transfer will be permitted for minimum 3 years unless he is not medically suitable for the present category.
5. He should be prepared to serve anywhere on southern Railway system.

It must be clearly understood that his employment under Government is temporary and services will be terminated at any time without notice, if such termination is due to the expiry of the officiating vacancy in which he may be appointed or due to his mental or physical incapacity or due to his removal or dismissal as a disciplinary measure after compliance with the provision of (Class (2) of Article 311 of the constitution of India. Otherwise his services will be terminated from time on giving 14 days notice given by either side without any reasons being assigned.
7. The appointing authority however, reserves the right of terminating his service, forthwith or before the expiry of the stipulated period of notice by making payment to them or the sum equivalent to pay & allowance for the periods of notice or the unexpired portion thereof. He should not resign or quit his employment except with the previous consent in writing or the head of the department or office in which he is employed.
8. In all matters not specifically provided for herein or in the recruitment rules, he will be governed by provision of the Indian Railway Establishment code and other extant orders as amended and issued from time to time.

The date of joining should be advised to all concerned immediately.
