In terms of CPO/MAS O.O cited, Sanction is accorded for the Inter Railway one way transfer of, Sri Babu Lal Meena, CTNC/RMM/MDU Dn in Pay Band Rs. 9300-34800 with GP Rs. 4200 to Jaipur Division North Western Railway.. in Pay Band -1 Rs.5200-20200 + Grade Pay Rs 1900 on bottom seniority in recruitment grade . The above One Way Inter Railway transfer is subject to the following conditions:

1. He will not seek retransfer to his Parent Railway at a later date.
2. He will not be eligible for transfer privileges as the transfer is ordered at his request.
3. He will take the seniority in the Division/Seniority unit to which he is transferred as per extant orders applicable to such one way request transfer on bottom seniority.
4. He should be free from DAR/SPE/Vig. Cases as on the date of relief.
5. If he is in occupation of Railway Quarters at the present station, the same should be vacated immediately, failing which action will be taken as per rules in force.
6. While issuing relieving letter , the instructions contained in Board's letter No. E(NG) 1-2001/TR/16 dt.21-11-2001 may be followed.
7. The employee may be directed to report to DRM/P/Jaipur Division for further posting orders.
8. The date of relief/ joining of Sri. Babu Lal Meena , may be advised to all concerned promptly.


