Query No:8. – What is total annual railway earnings of license fee for using Railway lands for Durga Puja, Kali Puja, Vishkarma Puja, Melas on railway lands over Indian Railways for last 20 years?

Information: Vacant Railway land has not been spared for Durga Puja, Kali puja, Vishkarma Puja etc. in this Railway. However, temporary licensing of railway land has been made for political/religious meetings with the specific approval of Railway Board and also for conducting circus shows.
