Regarding settlement bill against PO No.503/PC/24/12617 dated 31.12.12
for supply of Plate screw.
Ref: Your RTI application dated 03.03.15.

With reference to your RTI application dated 03.03.15, the following information is furnished:

Q.No	Information sought	Information furnished
1.	Reason for not making the payment of the above bill after the supplies were received.	The MOP 5&6 issued were not having requisite extension of delivery period for enhanced quantity because of which the bill was not paid.
2.	If there was any fault of the firm due to which the payment was not made.	Even though MOP-5&6 were issued on request of the firm, the deficiency in the MOP (as mentioned in para above) has not been notified by the firm to Railways till date. Based on Tiruchirappalli division's request on 30.03.2015, necessary modification to PO has been issued. Hence, the firm is also at fault due to which payment was not made.
3	Reason for not making the payment of PVC bill No.REC/31/2013-2014/S dated 16.06.2014 for Rs. 27,996/- and deducted money bill No.REC/31/2013-2014/S dated 12.09.2014 Rs.2,20,314/-.	The information is not available in this office. The same may be available with Sr.Divisional Engineer/Co-ordination and/or Sr. Divisional Finance Manager/Southern Railway, Tiruchirappalli.
4.	Reasons for not making the payment of L/D deducted by you amounting to Rs.3,73,386/- although delivery period extension was sent without L/D.
