1.	Please provide latest bridge design which is sent to you by state (Tamilnadu) highway for approval for construction bridge which is alternate to railway gate number 29 in Kanchipuram, Tamilnadu	Alignment details for road bridge as alternate for Railway gate has been prepared by Highways Department of Government of Tamilnadu. The same may be obtained from them.
2.	If you provide approval then please provide that approval copy. If you rejected then provide that copy too.	Railway approval pertains to only the portion from Railway Boundary to Boundary and is accorded in the drawings.
3.	If the latest bridge designs affect the two archeological temples irrevatheswaran and peravatheswaran temple which falls within 250 meets to railway gate no.	Structure within the Railway Boundary comes under Railway perview. The information sought is beyond Railway Boundary & hence not concerned with Railway administration.
4.	You guys got clearance from archeological survey of India for construction the bridge. If yes then provide copy of those details too.	The requisite approvals, if any required from archeological survey of India, is being dealt by State Highways Department and not by Railways.
