

The above promotion is ordered subject to the following conditions:


1. That the promotion will take effect from the date of shouldering higher responsibilities.
2. There is a probation period of 12 months in the promotion grade stipulated in Railway Board's letter No.E (NG) I-98/CN dt.05.08.2001 (PBC No.135/2001 dated 24.08.2001) at the end of the probationary period, if the appointing authority considers that the work of the railway servant serving the one year probation period on promotion has not been satisfactory or, the same is needed to be watched for sometime, she may revert the concerned employee to the post or grade from where the employee is promoted or extend the period of probation as the case may be.
3. That they are not placed under suspension and no departmental/criminal proceedings etc. pending against them. They are not undergoing any effective penalty debaring them for promotion.
4. The promotion should be given effect within a period of 10 days from the date of receipt of orders as stipulated.
5. Employees already granted financial up gradation under ACP/MACPS are not eligible for fixation of pay on promotion.

6. They may exercise option for fixation of pay within 30 days from the date of promotion under rule 1313 of R -II
7. The date of joining should be advised to all concerned immediately.
8. The above promotees should pass the typing skill at 30 words per minute in English or 25 words per minute in Hindi within a period of two years from the date of promotion and that their promotion will be provisional subject to acquiring the prescribed typing qualification within the stipulated period. If they fail to acquire the typing skill within two years they will be reverted to their parent posts from which they were promoted.
