The promotions ordered under Para III, IV above are subject to the following conditions:-

1. That they are not placed under suspension and no departmental/criminal proceeding etc., is pending against them. They are not under going any penalty debarring them for promotion.
2. The employees promoted above will be on probation for a period of 12 months from the date of shouldering higher responsibility in the promoted grade. Continuance of promotes in the promoted grade will depend on their performance and successful completion of probation period as per para 113 of IREM & and instructions contained in RBE No.148/2001 and PBC 135/2001. Non Completion of probation period is a failure on the part of promotee. In case , before the successful completion of probation period in the promoted grade if the promotee seeks transfer to a post from which he was promoted, his/her pay in lower grade/post on such reversion will be fixed at a stage what he/she would have drawn had he/she not been promoted .

3. **SR** The promotees may exercise their option for fixation of pay in the promotional grade within a period of one month from the date of assuming higher responsibilities under Rules 1313(FR 22-1(a) R-II. In case they do not exercise any option within the stipulated time, it may be noted that their pay fixed as envisaged under Rule 1313(FR 22) of R-II is final and no further option/revision is permissible.
4. The promotion should be given effect within a period of 10 days from the date of receipt of orders. If they are unwilling, their unwillingness letter may be obtained in writing and forwarded to this office immediately on expiry of 10 days time. If no intimation about the promotion given effect to /or relief of the employee received it will be construed that he is unwilling and he will be debarred for promotion for a period of one year from the date of issue of this order and juniors promoted in the meanwhile will supersede him in seniority. The employee's relief should not be delayed on the score that he has preferred an appeal and it is pending disposal. Under no circumstances, the above change should be delayed in being given effect to. Any lapse without proper justification will be viewed seriously. The actual date of relief and reporting for duty should be advised to this office promptly.
5. They should vacate railway quarters if any in occupation before relief or seek retention of quarter as per rules.
6. The promotion will take effect from the date shouldering higher responsibilities.

The date of relief/joining should be advised to all concerned.
