Band of Rs. 5200 – 20200 with Grade Pay Rs. 1800/- (Level I in
VII PC) of Traffic, Commercial and Catering departments
against 16-2/3% LDCE.

It is proposed to conduct a selection for promotion to the post of Ticket Examiner in
pay Band Rs. 5200 - 20200 with Grade Pay Rs. 1900/- in VI PC upgraded to Rs. 2000/-
(Level 3 in VII PC) from employees in the Pay Band of Rs. 5200 – 20200 with Grade Pay
Rs. 1800/- (Level I in VII PC) of Traffic, Commercial and Catering departments against
16-2/3% LDCE.

I No. of Vacancies:

- (i) Total vacancies ... 13

II The selection consists of Written Test and Record of Service.

III Employees eligible to apply:

- (i) All open line staff of Traffic, Commercial and Catering departments
working in the Pay Band of Rs. 5200 – 20200 with Grade Pay Rs. 1800/-.

IV Service conditions:

- (i) Employees applying for the selection should have passed
Matriculation.
(ii) Employees applying for the selection should have put in a minimum
of 2 years continuous service as on 28.05.2017. In the case of
persons initially appointed as Casual labourers who are granted
temporary status after 120 days of continuous services and finally
absorbed in regular Group 'D' vacancies absorption in a regular cadre
will be counted in reckoning the two years qualifying service. In the case
of SC/ST employees, they should also have the requisite minimum
service as in the case of others.

V Syllabus for the written Examination:

- (i) Written Test consists of one paper of 3 hours duration divided into two
parts. Part A & Part B.
(ii) Part A: Working knowledge of the Railway servant in English
language.
Part B: General standard of proficiency through questions in Arithmetic,

General Knowledge mainly pertaining to Railway Services. Answers for Part B may be written in English or in Hindi or in Tamil or in Malayalam. Those who are desirous of writing in English (or) in Hindi (or) in Tamil (or) in Malayalam should specify it in application form.

- (iii) There will be question to the extent of 10% of total marks allotted for the Written examination on Rules Governing implementation of Official language. However, answering the Official Language question is not mandatory.
- (iv) There will be no supplementary written examination.

VI **Medical Examination :**

Those who qualify in the written exam, if found already fit in medical classification below B2 will be subjected for medical examination for B2 medical classification.


VII **Training:**

- (i) The empanelled employees will be nominated for the Training course at ZRTI/TPJ. The standard of Training will be the same as for the Direct recruits.
- (ii) In case of failures in the first attempt in the training a second chance will be given.
- (iii) Successful completion of the Training is compulsory and those who fail to qualify in the Training will have no claim for absorption as Ticket Examiner in the Pay Band Rs 5200 – 20200 with the Grade Pay Rs. 2000/-.
- (iv) Employees after successful completion of Training should not seek reversion to their parent cadre at the time of posting.

VIII **Forwarding of applications:**

- (i) Employees who fulfill / accept the above conditions may submit their applications in the prescribed forms (Copy enclosed) to their supervisory officials latest by 21.06.2017.
- (ii) Supervisory officials shall collect the application and forward it in one bunch with a covering letter indicating the names of the volunteers to reach Shri M. P. LIPIN RAJ, Divisional Personnel Officer/ Madurai on or before 27.06.2017 through a special messenger (Office copy of the forwarding letter shall be placed on the concerned file maintained by the supervisory officials).
- (iii) Administration will not be responsible for non receipt of application sent in piecemeal.
- (iv) Applications received after 27.06.2017 will not be entertained.
- (v) Wide Publicity shall be given duly exhibiting the copy of this letter on the notice board
