विषय/Sub: Selection for the post of Goods Guard in Pay Band Rs.5200-20200 with Grade Pay Rs.2800 (Leve-5) against 15 % LDCE Quota (Vacancies-9; SC-2; ST-1; UR-6)

It is proposed to conduct a selection for filling up of 15 % of the vacancies under LDCE in the category of Goods Guard in Pay Band Rs.5200-20200 with Grade Pay Rs.2800.

I. No of vacancies -- 9 (SC- 2; ST - 1; UR - 6)

II. Employees eligible to apply & service conditions:-

- (i) All the serving regular non-ministerial Group 'C' employees in the Operating and Commercial Department working in Grade Pay Rs.1800, 1900, 2000 and 2400 are eligible.
- (ii) They should have 3 years regular service as on 21.06.2017
- (iii) Upper age limit 40 years as on 21.06.2017 (45 years for SC/ST employees)
- (iv) Educational qualification - Degree from a Recognized University.

III. Syllabus / Written Examination:

- (i) In terms of Railway Board's letter No.E(NG)1/2000/PM-1/41 dated 7.8.03, the selection for the post of Goods Guard in Pay Band Rs.5200-20200 + Grade pay Rs.2800 against 15% LDCE consists of written test only.
- (ii) There will be no supplementary examination.
- (iii) In terms of Railway Board's letter no. E(NG) I-2006/PM1/18 dt. 30.08.2006, the written examination will consists of objective type questions for about 50% (in the range of 45% to 55%) of the total marks, prescribed for written examination.
- (iv) Candidate should indicate in their applications, whether they require question papers in Hindi so as to answer the same in Hindi. Option once exercised will be final.
- (v) In addition to the syllabus, there will be questions to the extent of 10% of the total marks allotted for the written examination on the rules governing implementation of official language. However, answering the official language question is not compulsory.
- (vi) In terms of Bd's Ir.No.E(NG) I/90/PM141 dt. 08.07.92, use of regional language is permitted. The term 'Regional language' as used here means the official language of the State in which the office is located. Accordingly, use of Tamil is allowed. However, the knowledge of English for such employees who are writing the written examination in Tamil, will be separately tested.

- (vii) The suitability of the employees will be adjudged, based on their performance in the Written Examination and Record of Service. The employees should obtain 60% marks in the Written Examination and 60 % in the aggregate for being placed in the panel. Being a Safety category, no relaxation of marks will be allowed in respect of SC / ST employees.

IV. Medical classification for the post]
of Goods Guard as per Annexure]
II of IRMM] -- Aye Two

The employees qualified in the written examination have to pass medical examination in Aye two, if they are not already possess the medical classification of Aye Two.

V. Training.

- (i) The employees who are fit in Aye Two medical classification only will have to undergo training course for Goods Guards, for a period of 30 days, at ZRTI/ TPJ.
(ii) If they fail in the prescribed training at the first instance, they will be given a second chance to undergo repeat course.
(iii) If they fail in the repeat course, they will be reverted and sent back to their parent cadre, without further intimation.
(iv) The selected employees should not seek repatriation to their parent cadre at the time of posting or / and on passing requisite training. Such of those employees who are not willing to accept these conditions need not apply.


VI. Forwarding of application:-

The eligible volunteers shall handover the applications to the supervisory officials concerned latest by 15.07.2017 who will in turn forward the applications in one bunch in a cover addressed to Shri. M.P.Lipin Raj, Divisional Personnel Officer/ Traffic/MDU on or before 20.07.2017 with a covering letter specifying the Name/ Designation of the employee whose applications are enclosed. Applications received thereafter will be summarily rejected.

This Notification should be given wide publicity. All the Supervisory Officials should ensure that this notification is brought to the notice of all the employees of the feeder categories working under their control. The employees who are on leave / sick list, etc. should be notified of the Selection.
