विषय/Sub: Promotion of TTI in Pay Matix level: 6.

Shri K.Sonaimuthu, Sr.TE/SL/MDU (P.F.No.04502723) in the Pay Matrix level-5 (erstwhile Pay band of Rs.5200-20200 with Grade Pay Rs.2800), who is found fit on the basis of "Seniority cum Suitability" for the post of TTI is promoted as TTI in the Pay Matrix level-6,(erstwhile Pay Band of Rs.9300-34800 with Grade Pay of Rs.4200/-) as one time exemption in terms of Railway Board's letters No.E(NG)2008/PM-1/15 dated 03.09.09, 22.07.10, 21.11.2011, 23.05.12, 15.01.2013, 24.05.2013, 03.01.2014, 31.12.2014, 09.02.2016 & 03.03.2017 and retained at the existing station on promotion as TTI/SL/MDU. He is charged against UR vacancy.

The promotion is ordered subject to the following conditions:

- The promotion will take effect from the date of assuming higher responsibility.
- That there is no DAR/SPE/Vig cases pending/ contemplated against him and there is no prima facie case is pending against the employee as a result of fact finding enquiry or otherwise and that he is not placed under suspension or no departmental proceedings have been initiated/proposed to be initiated at a later date or he is not undergoing any penalty debarring him for promotion.
- He should be relieved within a period of 10 days by the supervisory official and the onus of relieving the employee lies with the supervisory official. In case he is not willing to get relieved on promotion the fact should be reported to this office within 10 days and the same will be treated as refusal of promotion and consequently he will be debarred for promotion for a period of one year from the date of issue of this office order in terms of CPO/MAS letter No.P(R) 535/promotion Dt 10.01.97 and juniors promoted in the meanwhile will supersede him in seniority. This may also be notified to the employee specifically. Any such unwillingness should be obtained in writing and the original unwillingness letter should be forwarded to this office immediately.
- The supervisory official will take the responsibility to see that the employee is not retained on any administrative requirement in the post, from which he is promoted. In exceptional case, where the employee seeks a limited extension of stay in the post for a period not exceeding 3 months, competent authority may consider such request and indicate and notify the date by which the employee will be relieved to join the higher grades.
- The promotee is not eligible for transfer privileges on transfer account.



- Shri S.Murugan, Sr.TE/SL/MDU, Shri G.Pechiappan, Sr.TE/SL/TEN Shri S.Velavan, Sr.TE/SL/MDU are pass over for promotion, since they are undergoing effective penalty. They will be promoted with due seniority on expiry of penalty if eligible as per extant rules applicable at that time.
- The date of relief/Joining should be advised to this office promptly.
