Para II- The following employee of Tech Gr-I/TL (in Pay matrix level -5 [PB Rs 5200- 2020 GP Rs 2800/- **Pre revised**]) who have been found suitable for promotion to the post of Sr.Tech (TL) in pay matrix level-6 is promoted as Sr.Tech(TL) in pay Matrix level-6 (PB Rs 5200-2020 Rs.4200/-GP **Pre revised**) against existing vacancy and retained at MAQ.

The promotions ordered in favour of the above employee is subject to the following conditions.

- 1) The promotion of the employee will take effect from the date he assumes higher responsibilities

2) They are not undergoing any penalty debarring them from promotion and are free from DAR/SPE/Vigilance cases. In case any of the employees are undergoing any penalty at the time of their promotion it will be deemed that they are carry out current duties till such time they become free from punishment

3) The fixation of pay on promotion from one level to another is fixed in terms of RS (RP) rule, 2016 13 (i).

4) The above named employees may exercise option for fixation of pay to get their pay fixed in the higher level either

(a) From the date of promotion or

(b) From the date of next increment in accordance with railway Board's letter No PC-VII/2016/1/6/2 dt.31-07-2017 (RBE No 79/2017) along with office Memorandum No. 13-02-2017-Esst.(Pay-1) dated 27-07-2017.

5) -The employee who is in receipt of Financial up gradation under MACP Scheme-2008 in the promoted pay matrix Level are not entitled for further fixation pay on promotion.

6) The promotion order is provisional and subject to outcome of the main SLPs and contempt petition (C) No. 314/2016 in SLP (C) No. 4831/2012.

7)The promotion is ordered on the condition that there are no prima facie cases pending against him as a result of fact finding enquiry or otherwise and that he has not been placed under suspension or no departmental proceedings has been initiated against them or there are no proposal to initiate proceedings at an early date or they are not undergoing any penalty debarring them from promotion.

8) SI.No.1 in Para I is not eligible for any transfer privileges on transfer account and SI.No. 2 is eligible for all transfer privileges on transfer account.

9) They should vacate Rly.Qtrs. immediately on relief if any occupied by them. If they propose to retain the quarters as per extant orders, they should apply in time for retention and obtain prior permission. Retention of Rly. quarters without/beyond permission will attract deduction of damaged rate of rent.
