Smt . V.Vinitha,PF No : 15551200016, ECRC II/Sr.DCM/O/PGT in Pay Matrix Level-05 (GP Rs.2800/-) who has been selected and empanelled for the post of Complaints Inspector (Ex-cadre) in Pay Matrix Level-06 (GP Rs.4200/-) , is posted as Complaints Inspector in Sr.DCM/O/PGT .

उपर्युक्त तैनात निम्नलिखित शर्तों पर निर्भर है । The above posting as complaints Inspector is subject to the following conditions.

1. Her posting as complaints Inspector is on a tenure basis for a period of four (4) years .
2. She will continue to retain her seniority in her parent cadre.
3. She will be repatriated on completion of her tenure period. However nothing will preclude the administration from repatriating her to her parent cadre at any time , during the tenure period without assigning the reasons therefore.
4. कि उनके विरुद्ध कोई अज्ञानि/विपुस्था/सतर्कता का मामला लंबित नहीं है तथा वे ऐसे कोई सजा नहीं भोग रहे है जो उसे तैनात से विवर्जित करें । There are no DAR/SPE/Vigilance cases pending against her and is not undergoing any punishment debarring her from the above posting.
5. The above posting is provisional subject to the final outcome of varies court cases pending before Hon'ble Supreme Court, High Court, Central Administrative Tribunal etc.
6. The above promotions are subject to the outcome of the main SLP and Contempt Petition No.(C) 314/2016 in SLP (C) No.4831/2012 pending before the Hon'ble Supreme Court and other cases pending before various other courts.
7. उच्चतर दायित्व संभालने की तारीख से उपर्युक्त तैनात प्रभावी होगी । The above posting will take effect from the date of assuming duty as Complaints Inspector .
8. भारमुक्ति/कार्यग्रहण/उच्चतर दायित्व संभालने की तारीख सभी संबंधितों को यथासमय सूचित की जाए । The date of relief/joining/assuming higher responsibilities may be advised to all concerned in time.
