The promotion are subject to the following conditions:-

1. They are not placed under suspension or no departmental proceedings is pending against them. They are not undergoing any penalty debaring them for promotion.
2. The employees promoted above will be on probation for a period of 12 months from the date of shouldering higher responsibility in the promoted grade. Continuance of promotees in the promoted lower grade / post on such reversion will be fixed at a stage what they would have drawn had they not been promoted.
3. The promotion should be given effect within a period of 10 days from the date of receipt of orders. If they are unwilling, their unwillingness letter may be obtained in writing and forwarded to this office immediately on expiry of 10 days time. If no intimation about the promotion given effect to / or the relief of the employee received it will construed that they are unwilling and they will be debarred for promotion for a period of one year from the date of issue of this order and juniors promoted in the meanwhile will supersede them in seniority. The employees relief should not be delayed on the score that they have preferred an appeal and it is pending disposal. Under no circumstances, the above changes should be delayed in being given effect to. any lapse without proper justification will be viewed seriously. The actual date of relief and reporting for duty should be advised to this office promptly.


