It is proposed to conduct a selection for filling up the vacancies of the post of Shunting Master Gr.II in Level 4 in VII PC Pay Matrix from among CMan I in Level 4 in VII PC Pay Matrix .

i) No. of vacancies

SC : 3

ST : 1

UR : 20

ii) Mode of selection

Selection consists of written test only.


iii) Employees to be alerted

The staff shown in the enclosed list who are working in Level 4 in VII PC Pay Matrix as CMan I may be alerted to be in readiness to appear for the above selection on the dates to be notified shortly.

Syllabus for written examination : The Syllabus for written examination to be conducted as a part of selection procedure as communicated vide CPO/MAS Lr No. P(S)529/II/AVC/Vol.V dated 02.01.04 is enclosed in annexure.

iv) In terms of Railway Board's letter No. E(NG) I-90/PM1/41 dt 08.07.92 and CPO/MAS Lr. No.P9L0694/GM/PNM/ATR/2016 Dt.22-07-2016 Examination will be conducted in vernacular language (Tamil& Malayalam),the employees alerted are permitted to write the examination in their regional language i.e., Tamil /Malayalam besides English and Hindi. However there shall be questions set to test English knowledge to ensure that the persons would understand the instructions relating to the requirement of the job.

v) They may also be advised that in terms of Railway Board's letter No. E(NG) 2000/PM1/41 dt 07.08.03, 45% to 55% of total marks will be of objective type questions and that there will be no negative marking for the wrong answers to the objective type questions.



vi) They may also be advised that for 10% of the total marks , there shall be questions set on official language policy and rules.

Pre-Promotional Training : The employees belonging to reserved community shall be imparted pre-promotional training .

The selection is on Divisional basis. The staff who appear for selection in the event of being selected should be prepared to serve in any station in this division to which they may be posted.

vii) Communication of unwillingness : if any of the staff is not willing to appear for the selection the same should be communicated to this office on or before 26-03-2018 certain, duly sending their original unwillingness letter to the undersigned.

viii) Staff required to attend the above selection should not ordinarily be allowed to go on leave except in urgent cases. If any of the employees who are alerted does not appear for selection on the said date on their own volition they are not eligible to be considered at a later date for supplementary examination.

ix) The supervisory official will please send a report as per proforma enclosed about the working of CMan I working under them in one consolidated list in a name cover addressed to the undersigned.

x) Please ensure the employees mentioned are relieved in time and directed to attend the examination on the date which will be notified without fail. The employees under suspension or on sick/absent may also be advised to attend the examination without fail. In case of employees on leave /sick it is the duty of the supervisory officials to ensure that the date , time and venue of examination /training are advised to the employee.
