परोक्त कर्मचारियों के पक्ष में जारी पदोन्नतियों निम्नलिखित शर्तों पर निर्भर है।

The promotion ordered in favour of the above employees are subject to the following conditions.

1. उच्चतर दायित्व संभालने की तारीख से कर्मचारियों की पदोन्नति प्रभावी होगी।

The promotion of the employees will take effect from the date they assumes higher responsibilities.

2.They will be on probation for a period of 12 months from the date of entry in the promoted grade. Continuance of promotee in the promoted grade will depend on their performance and successful completion of probation period as per para 113 of IREM & Railway Board's letter No.E(NG)1-98/CN5/1 dated 02.08.2001. (RBE No.148/2001 & PBC No.135/2001) . Non-completion of probation period is a failure on the part of promotee. In case, before the successful completion of probation period in the promoted grade if the promotee seeks transfer to a post from which he was promoted , his pay lower / grade / post on such reversion will be fixed at a stage what they would have drawn, had they have not been promoted.

3. पदोन्नति इस शर्त पर आदेशित है कि उनके विरुद्ध तथ्यान्वेषण जाँच करके अन्य बातों के फलस्वरूप कोई प्रथम दृष्टि मामला लंबित नहीं है और वे निलंबन के अधीन नहीं हैं और उनके विरुद्ध कोई विभागीय कार्रवाई शुरू नहीं की गई है या निकटतम भविष्य में कोई कार्रवाई शुरू करने का प्रस्ताव नहीं है या वे ऐसी कोई सजा नहीं भोग रहे हैं जो उन्हें पदोन्नति से रोकें।

The promotion is ordered on the condition that there are no prima facie cases pending against him as a result of fact finding enquiry or otherwise and that they are not been placed under suspension or no departmental proceedings have been initiated against them or there is no proposal to initiate proceedings at an early date or is not undergoing any penalty debarring them from promotion.

4.The promotion ordered above should be given effect to within a period of 15 days from the date of receipt of this order. If the said promotee referred to above is not willing to be promoted within the period of one month, from the date of receipt of these orders, the same will be treated as refusal of promotion and consequently they will not be eligible to be considered for promotion before the expiry of one year from the date of refusal and they will lose place to all juniors who will be promoted in the meanwhile.

5. The fixation of pay on promotion from one level to another is fixed in terms of RS (RP) rule 2016 -13(i)

The employees may exercise option for fixation of pay to get their pay fixed in the higher level either

- from the date of promotion or
- from the date of next increment in accordance with Railway Board's letter No.PC-VII/2016/1/6/2 Dt-13.02.2017-Esst (Pay-1) dated 27.07.2017

6. The employees who were on receipt of Financial upgradation under MACP Scheme-2008 in the promoted pay matrix level is not entitled for further fixation of pay on promotion.


7. The promotion order is provisional and subject to outcome of the main SLP's and contempt Petition © No: 314/2016 in SLP © No:4831/2012.
