The above promotion is ordered subject to the following conditions

1. The promotion will take effect from the date of assuming higher responsibility.
2. That there is no DAR/SPE/Vig cases pending/ contemplated against them and there is no prima facie case is pending against the employees as a result of fact finding enquiry or otherwise and that they are is not placed under suspension or no departmental proceedings have been initiated/proposed to be initiated at a later date or they are not undergoing any penalty debarring them for promotion
3. In terms of RBE No.117/2012, the promotions are provisional and subject to the outcome of the pending contempt petition Civil No.314/2016 and SLP Civil No.4813/2012.
4. The above selection/promotion has been initiated/ordered only after ascertaining quantifiable data of representation of SC and ST employees in the grade, as per the post based roster. Accordingly the following promotion orders are issued in compliance with the direction of the Hon'ble Supreme Court in M.Nagaraj case.

a) either their initial pay may be fixed in the higher post on the basis of Rule 1313 I(a) 1 R.II straightaway without any further review on accrual of increment in the pay scale of the lower post.

Or

b) their pay on promotion may be fixed initially at the stage on a time scale of the new post above, the pay in the lower post which may be prefixed on the basis of the provisions of Rule 1313 R.II FR 22 I(a)(1) on the date of accrual of next increment in the scale of the lower post. In case they did not exercise option within a period of one month from the date of shouldering higher responsibility it may be noted that their pay will be fixed as envisaged under Rule 1313 FR 22 I (a) (1) of R.II.

c) The employees who have already been granted FU under MACPS to the above grade Pay are not eligible for further fixation of pay.

Para II SNo. 1 is eligible for all transfer benefits.

Para III SNo. 2 is eligible for all transfer benefits, since the transfer is ordered on admn. grounds

Para VI SNo.1 TO 7 are eligible for all transfer benefits



If they are in need of continued occupation of Railway quarters, for eligible specific reasons, they should apply for permission well in time to retain quarters for the permissible period. They should note that damage rent will be recovered if they retains the quarters beyond the permitted period without further advice to them.

The date of assuming higher responsibility should be advised to this office immediately.
