

Shri. Dilip kumar (SC) PF/Employee No.15529800537,JE/Elect/TRD/PSI/Ull, in Pay Matrix Level-6 PGT Division Southern Railway, is transferred to DRM/O/BCT Mumbai Central, Western Railway on Inter Railway Mutual Transfer with Shri.C.V.Saji.(SC) PF/Employee No.736516 JE/TL/BCT Mumbai Central Division Western Railway in Pay Matrix Level-6 subject to the usual terms and conditions applicable to such transfer.

The above Inter Railway mutual transfer is ordered subject to the following conditions:

1. They will take seniority of the unit to which they are transferred as per extant orders as applicable to mutual transfer i.e they will either retain their own Seniority or take the seniority of other employee whichever is lower.
2. They will not seek re-transfer to their parent Railway at a later date with their original seniority. They are not entitled for any privileges on transfer account viz joining time, composite transfer grant, and transfer pass etc. as the transfer is ordered at their own request.
3. They should be prepared to serve anywhere on Southern Railway and Western Railway to which they are transferred on mutual basis.
4. They should be free from DAR/SPE/Vig Cases.
5. They should vacate the Railway quarters, if occupied, immediately on their relief. Failure to comply will be treated as unauthorized occupation and appropriate action will be taken against them under DAR.



6. They should handover all the materials pertaining to Railways which were entrusted to them in the course of their work to their immediate supervisor.

7. No request for back tracking from the mutual exchange arrangement will be entertained under any circumstances as per the instructions.


8. The transfer is to be carried out in terms of Railway Board's letter No.E(NG)-2001- IR/16 dated 21.11.2011.

A declaration accepting the above conditions should be obtained from the employees before they are relieved on transfer and a copy of the same is to be forwarded to this office for record. While relieving the employee the relieving memo should consist of the recent photograph and specimen signature, duly attested by the officer signing the releasing memorandum/order with officer name and designation appearing below the signature.

9. As per Rly Bd's letter No.E(NG ) I-2017/TR/24 dt.09.05.2018 ( RBE 65/2018 ) Shri.C.V. Saji. PF/Employee No.13736516 JE/Elect/TL/BCT Mumbai Central Division Western Railway may be relieved to this Divisional at the earliest.

The date of relief /joining should be advised to all concerned.
