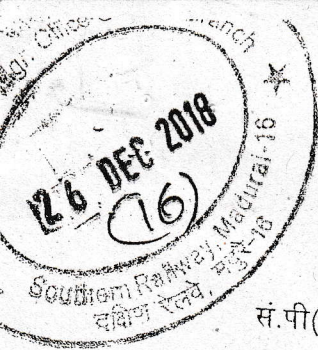

There will be **no Supplementary Examination.**


