
The re-engagement order in favour of the above employee is subject to the following conditions:

1. Supervisor is advised to direct the re-engaged employee for PME and RC, if due.
2. Supervisory officials are advised strictly to ensure whether the employee is medically fit in the medical classification (Bee One) The Scheme is operative only till 01.12.2019 unless and until extended by Railway Board through further instruction.
3. Re-engagement is purely on temporary basis and his services will be terminated as and when suitable regular incumbents joins the post either by way of recruitment or by transfer or on attaining the age of 65 (Sixty five) whichever is earlier or on cessation of the scheme or due to surrender of post due to man power planning.
4. Monthly remuneration of the Re.-engaged retired Railway Staff will be determined by reducing the Pension from their last Pay Drawn (i.e, Basic + DA) as per RBE No 150/2017.
5. The applicant should not have been covered under LARSGESS or any other like schemes.
6. The working hours of re-engaged staff will be same as that of the regular staff in similar post.

7. The remuneration of re-engaged staff in Administrative offices and Open line will be calculated on monthly basis duly including the Saturday & Sunday, closed Holidays and the period of rest as applicable of them respectively.
8. When they are sent on duty outside the station /Hqrs they may be paid daily allowances at the rate of 60% applicable daily allowance rate in addition to their daily wages/remuneration (RBE 24/2017). They are eligible for duty pass as per eligibility at the time of retirement /or on the basis of their post in which they are re-employed.
9. The period of such reengagement will not be counted as service for any purposes as admissible to regular serving employee.
10. Re-engaged staff will not be eligible for any coverage under ECA, PWA, payment of Gratuity Act or any other statutory enactment admissible to serving Railway employees.
11. Re-engaged staff will not be entitled for PLB or any other extra benefits admissible to serving employees.
12. Re-engaged staff will not be covered by any of the welfare Scheme, CGA, Ex Gratia, Funeral Advance etc. as admissible to regular employees.
13. Re-engaged staff will not be entitled for any advances as admissible to regular employees.
14. The above re-engagement will take effect from the date of her joining the post.
15. The date of joining may be advised to all concerned.
